#### **Critical Evaluation:**

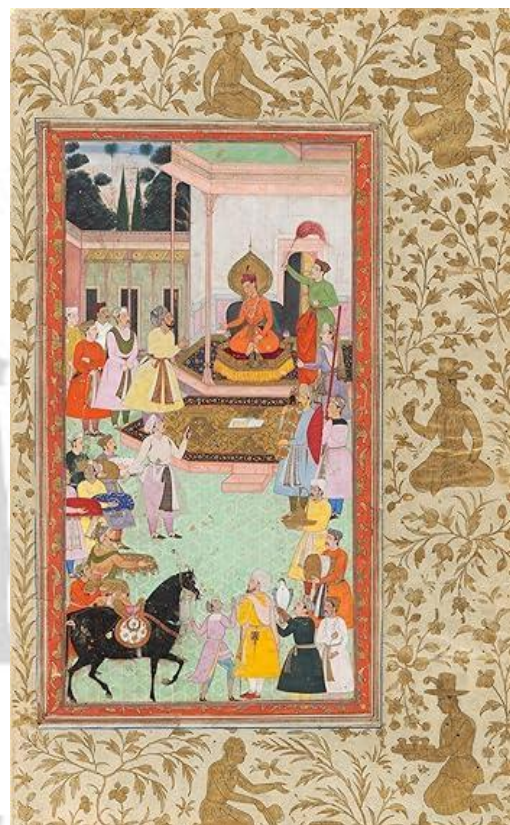
Modern historians cross-reference these accounts with archaeological and indigenous sources to filter biases. Despite limitations, they remain indispensable for reconstructing medieval history.

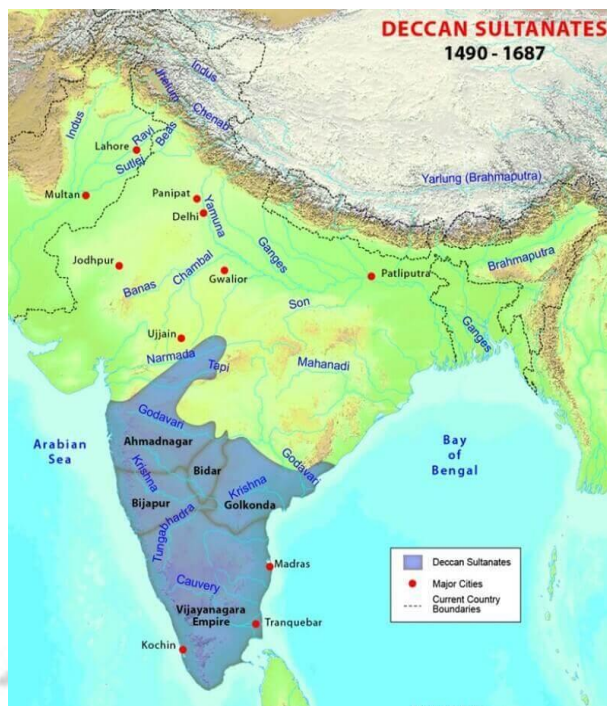

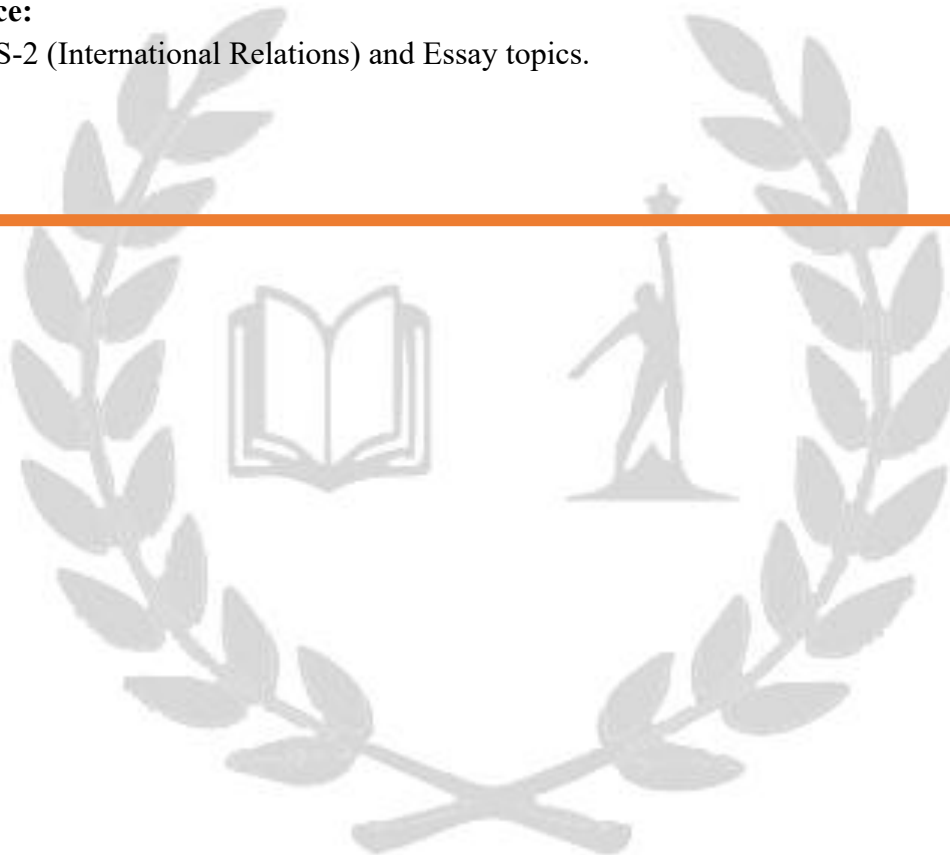
