



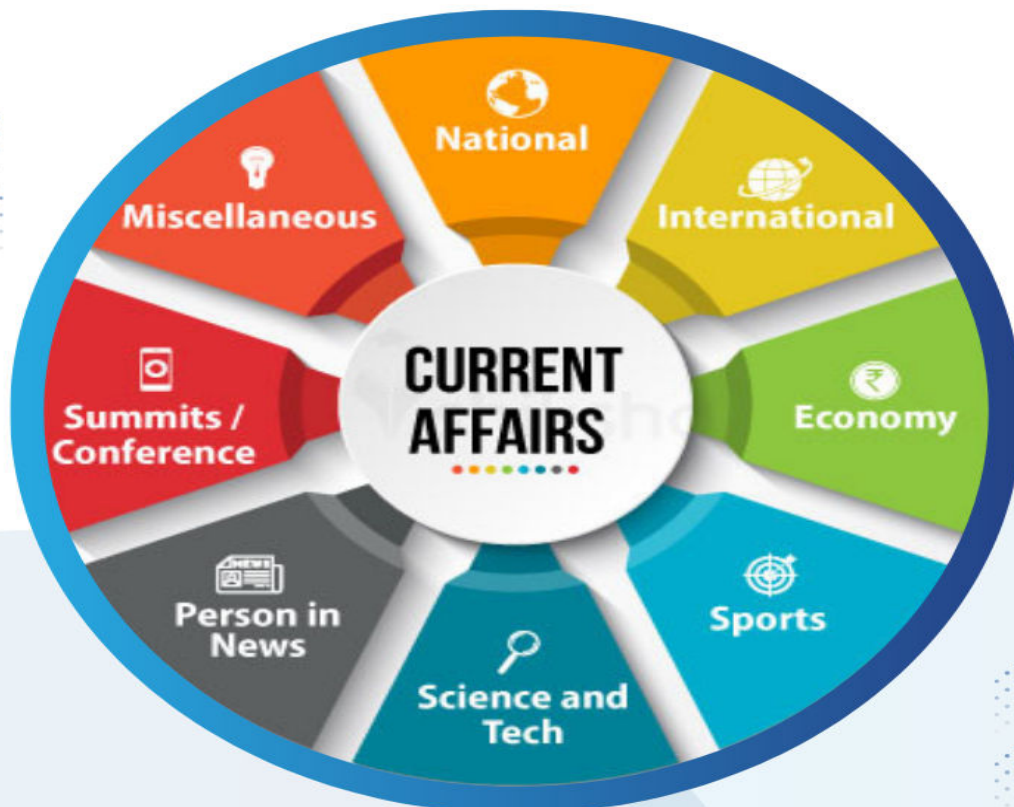

1. Sustainable Cultivation of Kutki in Himachal Pradesh

Key Highlights & Summary

- **Conservation breakthrough:** Farmers in Himachal Pradesh's Mandi district have pioneered sustainable cultivation of Kutki (*Picrorhiza kurroa*), shifting from destructive wild uprooting to scientific farming.
- **Innovative harvesting method:** Instead of plucking the entire plant which kills it, cultivators harvest only the side **stolons**, leaving the mother plant intact for continuous perennial production.
- **Research backing:** The Himalayan Research Group (HRG) under the Department of Science and Technology spent over a decade developing this alternative technique, which now spans nearly 180 farmers across Mandi.
- **Economic empowerment:** The initiative has transformed into the largest private land cultivation cluster for this endangered species, providing rural mountain communities with a reliable additional source of income.
- **Global trade alignment:** Sustainable production allows farmers to legally sell dried herbs through regulated channels, securing international compliance and fair market returns.

Essential Definitions

- **Kutki (*Picrorhiza kurroa*):** A high-value perennial alpine and sub-alpine medicinal herb native to the Himalayas (2,700–4,500 metres), widely used in traditional Ayurvedic formulations for its hepatoprotective and digestive properties.
- **Stolon:** A horizontal branch or creeping stem that grows along the soil surface, possessing nodes from which roots and new plants sprout, enabling vegetative propagation without destroying the parent organism.

Legal and Constitutional Framework

- **IUCN Red List Status:** Classified as **Endangered** due to decades of overexploitation, destructive wild harvesting, habitat loss, and restricted geographic ranges.
- **CITES Listing:** Included in **Appendix II** of the Convention on International Trade in Endangered Species of Wild Fauna and Flora, which regulates international trade through permits to prevent survival threats.
- **Constitutional Provisions:** Promotes the directive principles of state policy under **Article 48A**, which mandates the State to protect and improve the environment and safeguard forests and wildlife, alongside **Article 51A(g)** outlining citizens' fundamental duty to protect natural ecosystems.

The transition from wild uprooting to scientific stolon-based cultivation of Kutki models a symbiotic pathway between biodiversity conservation and rural economic development. Scaling such location-specific agricultural interventions is crucial for safeguarding fragile Himalayan ecosystems while securing sustainable livelihoods for mountain communities.

2. Odisha State Policy to Curb Human Trafficking

Key Highlights & Summary

- **New state policy initiative:** Odisha has proposed a new state policy titled **Nutana Sakala** (New Dawn) to tackle human trafficking through comprehensive measures spanning community-level prevention and asset confiscation.
- **Administrative formulation:** The draft policy is being prepared by the Women and Child Development Department and has been circulated among top police leadership including the Director General of Police and Crime Branch wings.
- **Grave statistical reality:** According to National Crime Records Bureau (NCRB) data, Odisha recorded 1,475 victims in 2021, 1,120 in 2022, 1,305 in 2023, and 1,039 in 2024, highlighting a persistent crisis.
- **Judicial and conviction gaps:** Despite identifying hundreds of survivors and arresting traffickers, systemic gaps remain, underscored by a historical record of zero convictions in certain evaluation cycles and lower chargesheeting rates.
- **Best practices integration:** The proposed policy draws upon successful prevention, protection, and prosecution models adapted from other Indian states and international frameworks.
- **Asset confiscation strategy:** A radical core feature of the policy includes targeting financial networks through the legal seizure of assets linked to human trafficking syndicates.

Essential Definitions

- **Human Trafficking:** The recruitment, transportation, transfer, harbouring, or receipt of persons by means of the threat or use of force or other forms of coercion, abduction, fraud, deception, or abuse of power for the purpose of exploitation.

- **Specialized Statutes:** The Immoral Traffic (Prevention) Act (ITPA) and the Protection of Children from Sexual Offences (POCSO) Act provide robust legal backing for prosecuting offenses related to commercial sexual exploitation and child trafficking.

Conclusion

The introduction of the Nutana Sakala policy reflects a crucial administrative acknowledgment of systemic gaps in combating human trafficking in Odisha. Effective implementation will require seamless coordination between law enforcement agencies, rigorous investigative chargesheeting, and community-driven rehabilitation ecosystems to dismantle criminal syndicates permanently.

3. India's Stance on Zero Tolerance for Terrorism and Maritime Security

Key Highlights & Summary

- **Zero tolerance doctrine:** External Affairs Minister S. Jaishankar firmly reiterated India's policy of zero tolerance toward terrorism at the 33rd ASEAN Regional Forum (ARF) Ministerial Meeting in Manila, emphasizing that acts of terror will face direct consequences.
- **Choking financial networks:** The address underscored the critical need to disrupt and dismantle financial ecosystems and funding channels that sustain terrorist networks globally.
- **Multilateral counter-terrorism leadership:** India highlighted its proactive role as co-chair of the Experts' Working Group on counter-terrorism under the ASEAN Defence Ministers' Meeting Plus (ADMM+) framework alongside Malaysia, driving the compilation of international best practices.
- **Maritime domain awareness:** India's security initiatives, including the Information Fusion Centre (IFC) and the Indo-Pacific Maritime Domain Awareness framework, were highlighted for countering piracy, trafficking, and securing international shipping lanes.
- **Freedom of navigation:** Expressing deep concern over attacks on commercial merchant vessels and civilian infrastructure in conflict zones, India advocated for safe, unimpeded commerce through global waterways and compliance with international law.
- **South China Sea adherence:** India voiced support for a substantive, effective, and legally binding Code of Conduct (CoC) in the South China Sea that remains fully compliant with the 1982 UN Convention on the Law of the Sea (UNCLOS).



Essential Definitions

- **Zero Tolerance for Terrorism:** A hardline national security posture advocating absolute rejection of any form of terrorism, eliminating distinctions between perpetrators and state sponsors, and ensuring decisive punitive actions against terror acts.

4. Parliamentary Panel Recommendation on Virtual Digital Assets

Key Highlights & Summary

- **Regulatory vacuum identification:** The Parliamentary Standing Committee on Finance has called for a comprehensive examination and a robust regulatory framework for Virtual Digital Assets (VDAs) such as cryptocurrencies under the Securities Market Code.
- **Interim self-regulation mechanism:** Pending a formal comprehensive legislation, the committee recommended introducing an interim framework via recognized Self-Regulatory Organizations (SROs) operating under designated regulatory oversight.
- **Massive retail participation:** Citing blockchain analytics data from Chainalysis, the report noted that nearly 12 crore Indians are actively participating in the domestic VDA ecosystem.
- **Investor protection and risk mitigation:** The panel warned that current exclusions and regulatory uncertainties expose investors to heightened risks of fraud, market manipulation, misrepresentation, and regulatory arbitrage.
- **Current taxation coverage:** While explicit civil securities legislation is absent, the sector is presently subjected to limited regulatory oversight purely for anti-money laundering compliance and taxation purposes.





- **Cross-border coordination:** The committee emphasized that any effective domestic framework for crypto-assets requires significant international cooperation and inter-agency domestic coordination.

Essential Definitions

- **Virtual Digital Assets (VDAs):** Digital representations of value issued through cryptographic means, functioning as a medium of exchange, unit of account, or store of value, excluding Indian legal tender and foreign currencies.

5. Bombay HC Lawyers Condemn Prohibitory Orders and Police Action

Key Highlights & Summary

- **Legal community condemnation:** Over 140 lawyers practicing before the Bombay High Court, including senior advocates, issued a strong statement deprecating prohibitory orders restricting public movement and assemblies.
- **Circumvention of statutory limits:** The statement noted that successive prohibitory orders (July 7 to 21 and July 23 to August 6) with only a 24-hour respite appear intentionally designed to bypass the 15-day legal ceiling requiring state government sanction.
- **Call for withdrawal:** Lawyers demanded that the Mumbai Police Commissioner immediately withdraw the ban, arguing it curtails lawful citizen protests without adequate justification or accountability.





- **Mass detentions criticized:** The resolution expressed deep concern over mass detentions and arrests under the Maharashtra Police Act, 1951, pointing out that restrictions failed to demonstrate the least restrictive measures.
- **Police use of force:** The Bombay Bar Association also condemned reports of students being subjected to lathicharge and tear gas, emphasizing that democratic dissent is vital.

Essential Definitions

- **Prohibitory Orders:** Official administrative directions issued under statutory police powers (such as Section 144 of CrPC or respective police acts) to restrict assembly of a specified number of persons to prevent public disorder.
- **Right to Peaceful Assembly:** A fundamental democratic liberty enabling individuals to gather collectively in public spaces to express views, deliberate, and demonstrate peacefully.

Legal and Constitutional Framework

6. Rajasthan Amendment Allowing Political Workers in Community Liaison Groups

Key Highlights & Summary

- **Policy amendment:** The Rajasthan government has amended the Rajasthan Police Rules, 2008, via a July 19 notification, deleting the explicit clause that barred members of political parties or their affiliates from joining Community Liaison Groups (CLGs).
- **Massive state network:** Government data reveals there are 75,265 active CLG members distributed across various police ranges in the state, such as Ajmer, Udaipur, and Bikaner ranges, acting as a bridge between citizens and law enforcement.
- **Core functions:** CLGs assist police in gathering intelligence, tracking criminals, preventing crime, defusing social unrest, and improving overall police-community relationships at panchayat, beat, and ward levels.



- **Ineligibility criteria:** Despite removing political affiliation bars, other strict rules still render individuals ineligible, including court convictions, ongoing criminal trials, suspected criminal associations, or involvement in property disputes.
- **Political polarization debate:** The move has drawn sharp political criticism from opposition parties alleging partisan institutional packing, while proponents defend it as a step toward integrating grassroots community leadership into local security governance.

Essential Definitions

- **Community Liaison Group (CLG):** An institutionalized voluntary forum comprising local citizens, community representatives, and civil stakeholders designed to assist police forces in intelligence gathering, trust-building, and maintaining local public order.
- **Policing Governance:** The administrative mechanism through which law enforcement agencies maintain public safety, law enforcement compliance, and social harmony in partnership with community stakeholders.

7. DRDO Flight Test of Project Kusha Long Range SAM System

Key Highlights & Summary

- **Maiden flight test success:** The Defence Research and Development Organisation (DRDO) successfully conducted the first flight test of the indigenous **Kusha** Long-Range Surface-to-Air Missile (LR-SAM) system from APJ Abdul Kalam Island off the coast of Odisha.
- **Target interception:** The test was conducted against an electronic target simulating a high-speed, high-altitude aerial threat, which the missile system successfully intercepted at targets up to 400km away.



- **Indigenous defense capability:** Project Kusha aims to develop an indigenous long-range SAM system to protect strategic military and civilian infrastructure from diverse aerial threats, including fighter jets, missiles, UAVs, and large enemy aircraft.
- **Atmanirbhar Bharat impact:** Defense Minister Rajnath Singh hailed the test as a crucial milestone that will significantly eliminate India's import dependency for advanced high-altitude air defense systems like the Russian S-400.
- **Component synergy:** All weapon system elements, including missiles, advanced radars, and command-and-control centers, have been collaboratively developed by DRDO laboratories and domestic industry partners.
- **Mission Sudarshan Chakra integration:** Project Kusha and the Integrated Air Defence Weapon System (IADWS) form core pillars toward building a homegrown nationwide multi-domain security shield under Mission Sudarshan Chakra over the next decade.



DRDO conducted the maiden flight test of Long-Range SAM 'Kusha' from the APJ Abdul Kalam Island off the coast of Odisha.

8. Due Process and Police Use of Force During Protests

- **Judicial commentary controversy:** Chief Justice of India Surya Kant's oral remarks telling a lawyer seeking intervention against police excess not to "waste our time" highlighted a perceived disconnect between citizens and judicial institutions.
- **Disproportionate police force:** Reports from Delhi streets highlighted the use of excessive and disproportionate force, including pellet guns, lathicharges, and tear gas shells against student protesters.
- **Flouting of established protocols:** The police actions raised concerns over short-circuiting standard protocols laid down in Delhi Police Standing Orders and landmark Supreme Court rulings regarding crowd dispersal.
- **Principle of least invasiveness:** Editorial commentary underscored the failure to follow the judicial principle of "least invasiveness", such as utilizing water cannons before resorting to injurious methods like pellet guns.
- **Judicial recourse:** Acknowledging the complexities, the Delhi High Court agreed to hear two Public Interest Litigations (PILs) concerning the police excesses, emphasizing that due process remains paramount.

Essential Definitions

- **Due Process of Law:** A constitutional guarantee that ensures governments respect all legal rights that are owed to a person, balancing the power of law of the land and protecting the individual person from coercive state action.

9. The Green We Celebrate: Uttarakhand's Forest Diversion and Black Harela Protests

Key Highlights & Summary

- **Black Harela protest:** The traditional green festival Harela in Uttarakhand was marked by protests under the banner of "Black Harela" as citizens and youth opposed the proposed felling of 4,000 mature trees to widen national highways and link roads.
- **Massive forest diversion:** An RTI reply revealed that since the state's formation in 2000, \$46,203\$ hectares of forest land have been diverted for various infrastructure and development projects.
- **Ecological vulnerability in Doon Valley:** The planned tree felling threatens ecologically sensitive zones, including the Shivalik Elephant Reserve and critical wildlife corridors, exacerbating landslide risks and fragility in the Himalayas.
- **Capital city burden:** Dehradun alone accounts for 21,618 hectares, or nearly \$47\text{\%}\$, of all forest land diverted across Uttarakhand for infrastructural expansions such as the Bhaniyawala-Rishikesh highway.
- **Policy dichotomy:** Activists have raised concerns over the contradiction between state-backed afforestation drives like *Ek Ped Maa Ke Naam* and the large-scale commercial felling of centuries-old irreplaceable forest canopies.



Essential Definitions

- **Harela:** A traditional folk festival celebrated in Uttarakhand marking the onset of the monsoon and the sowing season, symbolizing new life, prosperity, and ecological harmony with nature.
- **Forest Land Diversion:** The legal or administrative reallocation of designated forest areas for non-forestry purposes such as road construction, mining, hydro-projects, and industrial expansions.

- **Congressional ratification hurdle:** The agreement requires formal ratification by the US Congress, where broad bipartisan support for Israel may trigger stiff opposition and intense scrutiny over safeguards.
- **Geopolitical balancing act:** Analysts warn the pact could embolden Iran further, push Saudi Arabia closer toward cooperation with China and Russia, and drastically alter the geopolitical balance in West Asia.

11. Commissioning of Submarine Hunter INS Malvan and Coastal Defense

- **Blue water freedom:** By establishing a dedicated anti-submarine screen along India's 7,500km coastline, these shallow water platforms free up larger warships to focus on critical blue-water power projection.

12. Fast-track Courts: Establishment, Performance, and Constitutional Scope

- **Prime Ministerial commitment:** Prime Minister Narendra Modi's recent push to establish fast-track courts (FTCs) for tackling paper leaks has brought renewed attention to their efficacy in curbing judicial delays.
- **Lack of central legislation:** There is no single central legislation governing FTCs; their establishment has historically been driven by recommendations of successive Finance Commissions and centrally sponsored schemes.
- **Funding and special focus:** Following a 2019 criminal law amendment and Supreme Court directives, the Centre launched a centrally sponsored scheme partially funded by the Nirbhaya Fund to fast-track rape cases and POCSO offenses.
- **Performance metrics:** As of January, 862 regular FTCs and 774 FTSCs (including 398 exclusive POCSO courts) operate across states and UTs, showing a disposal rate around 96% for specialized matters.
- **Persistent bottlenecks:** Despite high disposal rates, over 2.4 lakh cases remained pending in FTCs by the end of 2023, plagued by infrastructure deficits, investigative delays, forensic backlogs, and vacant judicial posts.
